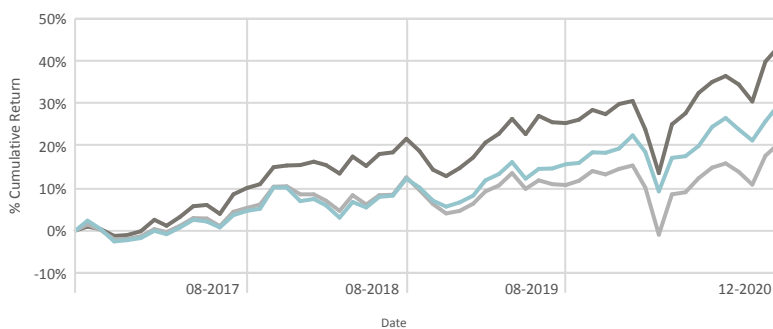
INVESTMENT OBJECTIVE

The Rowan Capital BCI Balanced Fund of Funds is to offer investors a moderate to high long term total return.

INVESTMENT POLICY

The portfolio will have investment instrument exposure across multiple asset classes in order to ensure portfolio diversification and therefore risk reduction. On a look through basis, the portfolio's equity exposure will range between 0% and 75% of the portfolio's asset value. The portfolio may invest in equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

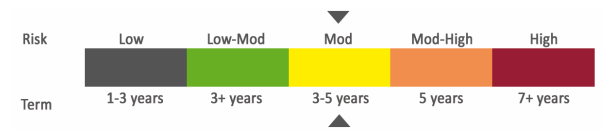

Moderate Risk

- This portfolio has a balanced exposure to various asset classes. It has more equity exposure than a low risk portfolio but less than a high-risk portfolio. In turn the expected volatility is higher than a low risk portfolio, but less than a high-risk portfolio.
